
"Shop Local SB" Program Update

GO-Biz California Competes Tax Credits

GO-Biz will begin accepting applications for the California Tax Credit (CCTC) on January 2, 2024. There are \$164 million in tax credits available during this application period. Applicants will be analyzed based on fourteen different factors of evaluation, including number of full-time jobs being created, the amount of investment, and strategic importance to the state or region. The application submission deadline is Monday, January, at 11:59 p.m. (Pacific Time)

The American Dream Awards Grant

The American Dreams Award grant is available to all for-profit businesses operating in the United States. If you become a recipient the package includes



\$1,000 in funding, access to a small business accelerator, media coverage, and other perks.

City of San Bernardino Opens Long-Awaited State Street Extension

The extension of State Street on the westside of San Bernardino has been completed and is now opened. The \$7.4 million project, initiated in the summer of 2022, involves the expansion of State Street from its termination point at Hanford Street by half a mile to the south, reaching Base Line. Subsequent stages of the project aim to further extend State Street beyond Base Line to Foothill Boulevard.
